Disclaimer 2022

The Guidelines for Ride-Outs are recommendations only. As a road user you have a responsibility to observe the Highway Code as well as all relevant legal and statutory obligations associated with riding a machine on the public highway. It is your responsibility ensure that you are sufficiently skilled to take part in a ride-out. At all times you have the sole and ultimate responsibility for your own safety and that of any passengers. If at any time you feel that an act if performed by you would be rash, unsafe or unlawful then you should not do it. You have a duty of care to your fellow riders, to other road users and to pedestrians to act in a safe and responsible manner. You join a ride-out at your own risk and HOG, Oxford UK Chapter Committee members, Road Captains and any other persons associated with the organisation of ride-outs in general can take no responsibility for loss, damage or injury to persons or property howsoever caused.

ADVISER FOR RIDERS

You are deemed to be in control of and responsible for your vehicle and you're riding at all times, irrespective of ANY GUIDANCE or INSTRUCTION from any of the road captains. You must ensure both the safety of yourselves and other road users; you must at all times ride within the law and obey road traffic regulations. If a road captain feels that your riding represents a danger to you or any other road users you will be asked to leave the ride out this is not negotiable. By participating in this ride you agree to these conditions.

Joining the H.O.G. Oxford UK Chapter:

A polite reminder of membership requirements and our operating policy. Members of the Chapter agree to abide by the Annual Charter for H.O.G. Chapters and must sign the annual membership application form which includes a Release, Chapter Operating Policy and Code of Conduct. Oxford UK Chapter membership runs from January 1st to December 31st. Cost is £20 per member. The cost for new members joining after September 1st is reduced to £10 for the months remaining in the year but the member will still be entitled to all Chapter benefits. All Chapter Members must have a current and active H.O.G. membership. With the purchase of a new Harley-Davidson, you should automatically receive one year's free H.O.G.® membership. If you buy a used Harley-Davidson through the Originals program, ask your Dealer for your H.O.G.® membership. Once you have your H.O.G.® membership number you will be able to join any H.O.G.® Chapter. (Please be aware that if at any time your H.O.G.® membership expires you also cease to be a member of the Chapter. All costs for joining are limited by H.O.G. but set by the Chapter. All Full, Associate and Life members of H.O.G. are welcome to join Oxford UK Chapter. To become an Associate member of H.O.G. you must be sponsored by a Full H.O.G. member. You will then be issued with your own H.O.G number by H.O.G. If you ride your own Harley-Davidson motorcycle you must have your own H.O.G. number to be an active member of any chapter. No motorcycles other than Harley Davidson or Buell may take part in Chapter arranged events / ride-outs without prior agreement with the organiser & Director unless invited to do so.

Any Member may join as many H.O.G. Chapters as they wish. However, membership of a H.O.G. Chapter other than Oxford UK Chapter may impact the member's eligibility of becoming a Chapter Officer. If the Member is also a Primary or Secondary Officer of a Chapter then they must not operate as a Primary or Secondary Officer of another H.O.G. Chapter, unless the Primary Officers of both or all Chapters concerned agree to the arrangement.

Guests of Oxford UK Chapter.

Guest Policy: Guests not accompanied by a Chapter Member of the Oxford UK Chapter may attend Open meetings or events only. They must be accompanied by a Chapter Member of Oxford UK Chapter at the AGM. Guests have no voting rights at the AGM or where necessary voting takes place. At all other meetings, events or ride outs Guests MUST be accompanied by a Chapter Member of Oxford UK Chapter. All Guests must sign the guest form and release and when the applicable annual fee has been paid, a Guest card will be issued.

Committee Meetings.

Committee Meetings will be held throughout the year to discuss and plan the day to day running of The Chapter. The Committee Meetings will be held monthly.. At every Committee Meeting detailed minutes are taken by the Chapter Secretary or an appointed representative of the Secretary. Minutes of Committee Meetings are available to Members upon request and published online in the Members Only area of The Chapter website.
